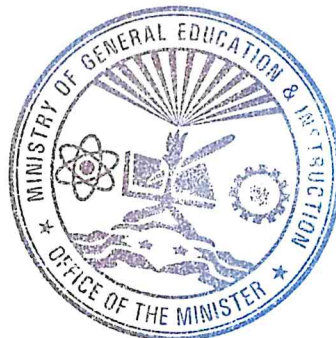

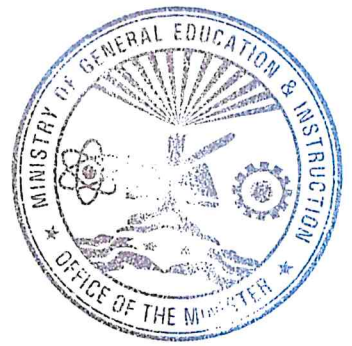

- d. exchange of learning materials and other information;
- e. release of staff on secondment to programs that promote PLEFS;
- f. pilot and standardize the integrated PLEFS curriculum
- g. Jointly train facilitators/ teachers for PLEFS;
- h. support facilitators/ teachers of PLEFS with incentives as budget allows ;
- i. promote the PLEFS approach within the line ministries and to external donors and partners
- j. Provide technical and policy guidance to PLEFS through the technical working group;
- k. other programs of educational exchange of interest to the Parties;
- l. Jointly develop sustainability plan and advocate for inclusion of PLEFS within relevant ministry budget to enhance sustainability
- m. Partnerships with other development partners to perform any of the above activities.

#### *Article 3*

#### ***SPECIFIC AGREEMENTS OF COOPERATION***

To achieve the objective of this Memorandum of Understanding, the Parties may jointly enter into specific agreements of cooperation which should specify the objectives, implementation timeline, human and material resources assignment, conditions and terms of funding and the responsibilities of each Participant, as well as other Parties associated with the Parties, for the protection of intellectual property rights, dissemination of results, as well as any other aspect that the Parties deem necessary. Once formalized, the specific agreements of cooperation should constitute an integral part of this Memorandum of Understanding.

#### *Article 4*

#### ***OTHER INSTRUMENTS***

The cooperation under this Memorandum of Understanding does not affect the rights and obligations acquired by the Parties under other international instruments to which they are a party.

#### *Article 5*

#### ***DESIGNATED PERSONNEL***

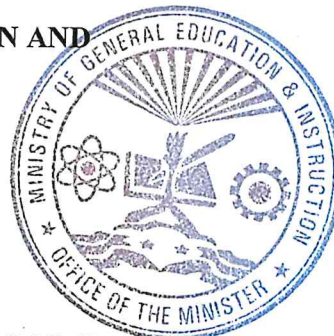
The personnel designated by the Parties for the execution of the activities related to the organization, implementation, supervision or any other action under the present Memorandum of Understanding should continue under the responsibility of their respective institutions, hence,

9.3. This Memorandum of Understanding may be modified with the mutual consent of the parties, through a written addenda signed by all parties. Such modifications will become an integral part of this Memorandum of Understanding and will be effective on the date of its signature.


9.4. Any Participant may terminate its participation under this Memorandum of Understanding, at any time, through written communication sent to the other parties, within six (6) months' notice of termination.


