- ii. Evidence of Tax compliance

Bidding will be conducted through Open National Competitive Procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers- Procurement in Investment Projects Financing" and is open to all eligible Bidders as defined in the Procurement Regulations that must have the following:

The method of payment will be Cash to the Project Finance Officer. The document will be sent by email, on instruction of the bidder or picked in person by bidders, whichever is convenient.
9. Bids must be delivered to the address below on or before **1 April, 2026**. Electronic Bidding **will not** be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders designated representative
10. Anyone who chooses to attend at the address below **10.00 hours Juba Local Time on 1 April, 2026**.
11. All Bids must be accompanied by a **Bid Security Securing Declaration completed Form**

12. All Bids must be accompanied by a Sexual Exploitation and Abuse (SEA) and/or Sexual Harassment (SH) Declaration.

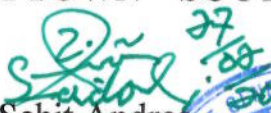
